1 Briefly describe the organization's mission: Community Partners of Dallas is a non-profit organization dedicated to ensuring safety and restoring dignity and hope to abused and neglected children by providing resources and support to the caseworkers of Dallas County Child Protective Services.

4a (Code:) (Expenses \$ 869,759 including grants of \$) (Revenue \$) RAINBOW ROOM - is an emergency resource center so that Dallas County Child Protective Services caseworkers may offer tangible help to families in need. This "store" has everything from clothing to blankets, diapers to shoes, hygiene products to home cleaning products. All products are available for caseworkers to bridge the gap for children who come into protective care with nothing more than the clothing on their backs. These services and products are provided without regard to the families served ability to pay. 8,207 children were served by the Rainbow Room in 2015.

4b (Code:) (Expenses \$ 71,664 including grants of \$) (Revenue \$) HEART PROGRAM - This program provides therapeutic group treatment to sexual-abuse victims and their non-offending family members. The Heart Program provides family-focused care with child protection as the primary goal. At the end of 2015 the program was serving 40-60 children and their family members every week; families average 4 months of therapy sessions.

4c (Code:) (Expenses \$ 147,432 including grants of \$) (Revenue \$) KIDS-IN-CRISIS - This program helps children served by Child Protective Services for needs not met in other ways. Kids in Crisis meets many categories of need: transportation, housing, enrichment activities, clothing, therapy, emergency needs and medical expenses. 5,978 children were served by Kids-in-Crisis program in 2015.
